- ❖ Permission to use the Farms of Tuolumne County promotional materials including the logo can be withdrawn by a vote of the Farms of Tuolumne County Board of Directors for failure to adhere to the membership agreement.
- ❖ The Farms of Tuolumne County membership year is January 1 through December 31 in each calendar year. Membership benefits including the use of the promotional materials and logo are designed for one (1) membership year only. Membership must be renewed annually to receive continued benefits.
