

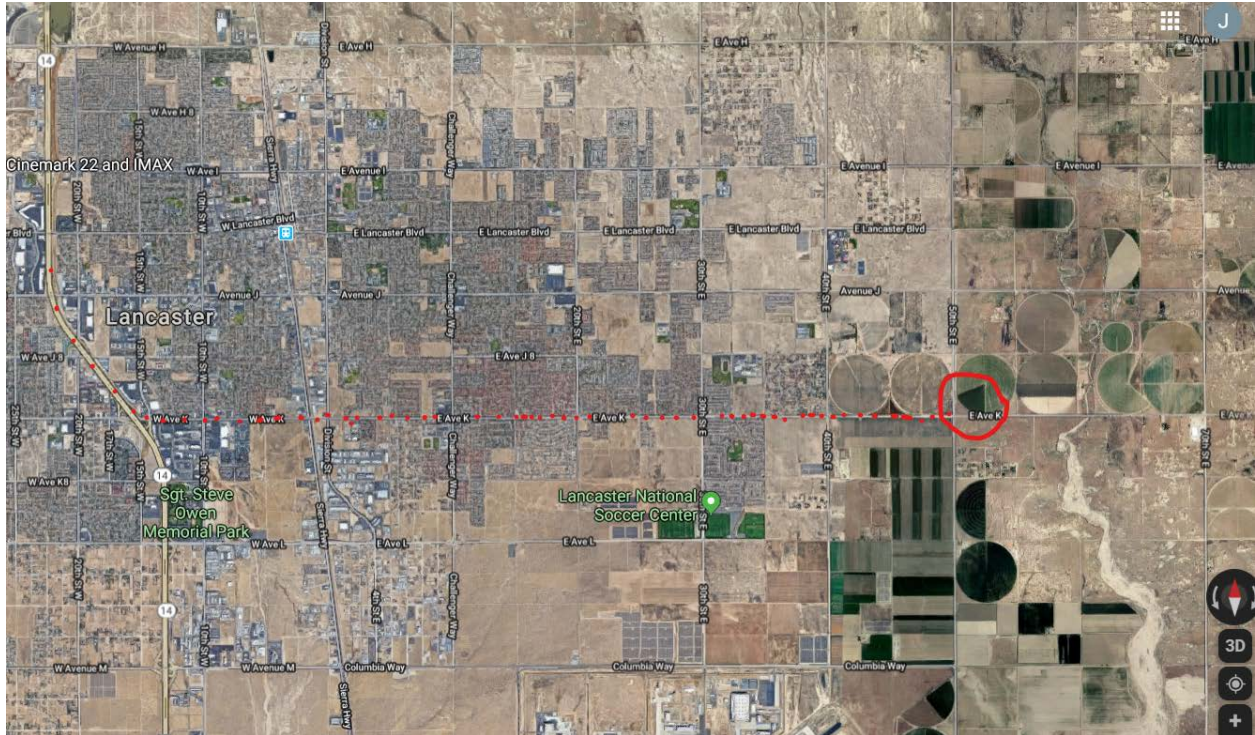
**Carrot Variety Trial Field Day
