## The California Farm Directory

- The Community Alliance with Family Farmers is launching an online tool called the California Farm Directory
- It will showcase local farmers and ranchers and allow consumers and distributors to connect directly with them.
- Eligible farms and ranches are:
  - o Based in California
  - Independent, family or cooperativelyowned
  - Commercial farm businesses (i.e. farm products are grown and sold by the farm. Nonprofit farms are permitted if they grow and call and/or distribute ager
    - they grow and sell and/or distribute agricultural products)



- The directory goes live in late August, but you can list your farm for free by following these instructions:
  - Visit <u>www.caff.org/directoryform</u> and click "Register" to create an account (or "Login" if you already have an account)
  - o Create a profile for your farm.
  - o Wait for your profile to be approved. A confirmation email will be sent.
  - o To revise or update your listing at any time, simply log back in, navigate to your farm's profile and click the "Edit" button at the bottom of the page.

## Growing the Table

- A new pilot program from a new nonprofit begins in **Fresno** and **Visalia** for small farmers affected by COVID-19
- Initiative will:
  - Provide smaller economically vulnerable, transitioning organic/certified organic, regenerative, women-owned, or BIPOC (Black, Indigenous, person of color) owned farms and ranches with a market alternative for their excess production during the ongoing COVID-19 pandemic
  - o Provide this food to struggling families in Fresno and Visalia at no cost.
- The program will buy produce at wholesale prices and provide a picking fee

## **USDA Organic Transition Funds**

- USDA's Farm Service Agency (FSA) announced that organic producers and handlers can apply
  for federal funds to assist with the cost of receiving and maintaining organic certification through
  the <u>Organic Certification Cost Share Program</u> (OCCSP). Applications for eligible certification
  expenses paid between Oct. 1, 2019, and Sept. 30, 2020, are due Oct. 31, 2020.
