Directions on How to Fill out Opt-In Sensitive Site Application (Reverse Side)

A sensitive site is defined as a location inhabited or frequented by at-risk people (such as elderly, young children, or individuals with medical conditions) or confined animals. These sites have demonstrated need for a greater safety buffer from managed bee hives (apiaries). The required distances will be measured between the location of the apiary and the property line of the sensitive site.

Individuals and businesses may apply to have their location designated as a sensitive site, subject to review and approval of the Commissioner. If you would like to apply to have your location designated as a sensitive site, please complete the form on the reverse side with the requested information.

You will need to provide:

- Your name/address/contact information.
- The address of the potential sensitive site if it differs from your home address.
- The reason for applying (business, allergy, elderly, daycare, etc.).
- Please describe your situation in detail and provide any supporting documentation or maps as needed.
- If you are a business owner, please provide a copy of your business license showing business name, license and phone number.
- You must please complete one form for each location being considered.
