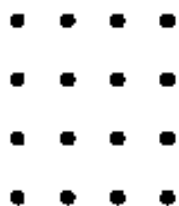
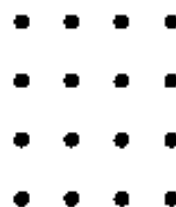

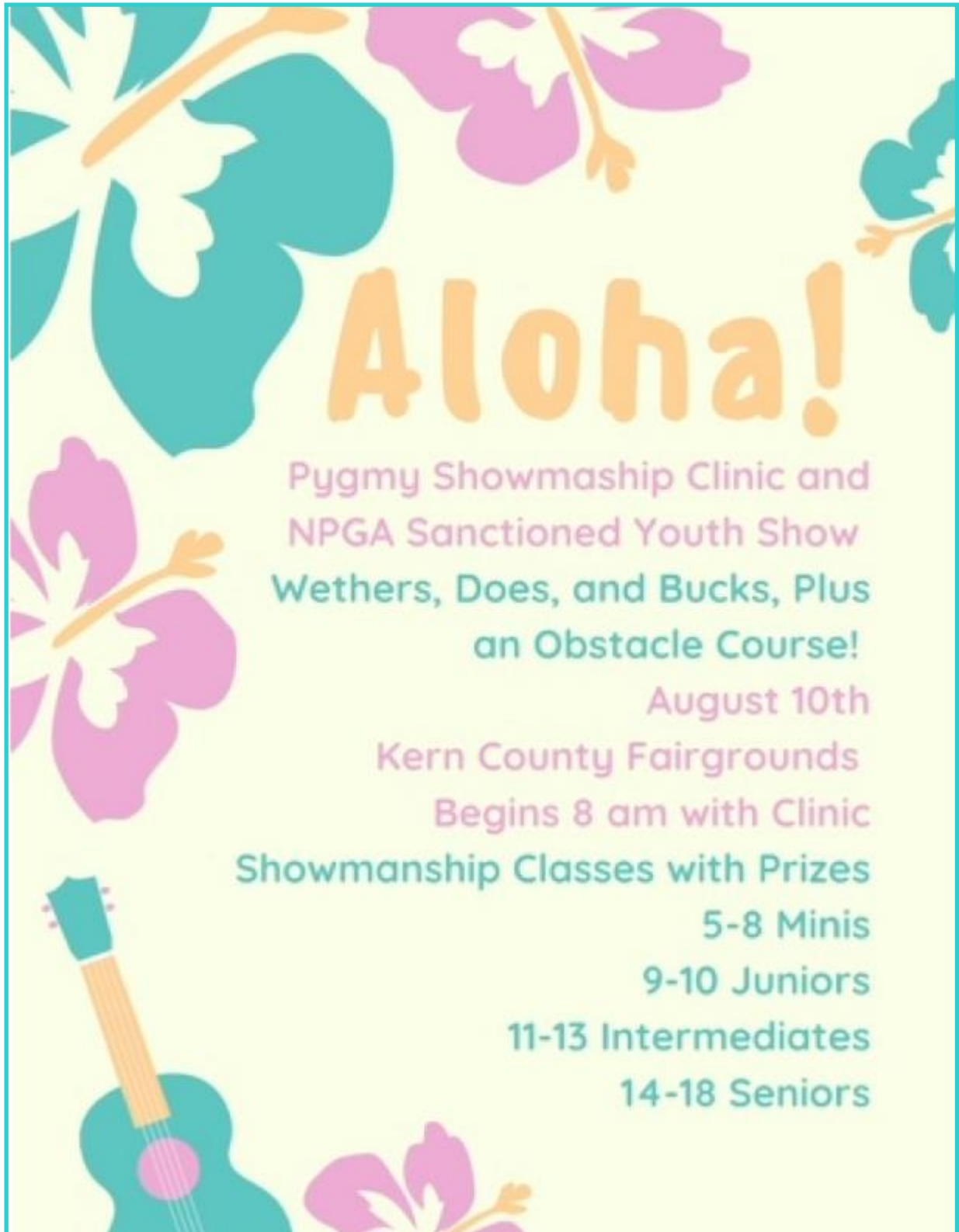

2024 MAJOR CHANGES SUMMARY

BELOW PLEASE FIND SOME OF THE MAJOR CHANGES FOR THE YEAR:

- **ALL MARKET SWINE EXHIBITORS- MUST** upload a Prop 12 Breeder Certificate to their showworks market swine entry by the close of entries.
- **SCHEDULE CHANGES-** Show schedules have been changed to allow for kids to miss less days, be sure to double check the schedule for all the time changes.
- **AG MECHANICS-** Projects that will be selling in the Auction will only enter in the Livestock Ag Mechanics Portion. They will be displayed in Livestock and will be judged in Livestock. If you are not interested in Selling then you will enter in the Still division in the building.
- **CREDENTIAL DISTRIBUTION-** Passes will be distributed from the livestock office on Saturday September 14th and Sunday September 15th. Once Entries Close an email will be sent to the leaders and exhibitors letting them know which day their pass will be available. The exhibitor must be there in person to pickup their pass.
- **POULTRY BARN CLEANING/FEEDING -** All animals are to be fed/watered and cage cleaned between 6am and 8am and Fed/Waterd between 4pm and 9pm.
- **EXHIBITOR ASSISTANCE -** Notwithstanding safety concerns, junior exhibitors are to groom and care for their animal(s) when at the fair. Parents and leaders may assist in cleaning stalls and feeding animals. Under no circumstances shall a parent, leader, trainer, non-exhibiting youth, or an entered youth but not exhibiting assist in any way during the grooming and fitting process (includes rinsing, washing, drying, leading, riding and show preparation). Failure to follow this rule will result in expulsion of entries, exhibitor and unauthorized assistant.
- **SHOWMANSHIP DIVISION ADDED -** Due to the large number of FFA Exhibitors we have added a division to split the FFA by grade. Please see the showmanship breakdowns on page 79
- **ADD ONS -**Add Ons will only be accepted online and must be paid for online if the total is less than \$250 or they will be removed at the conclusion of the online auction process.
- **INDEPENDENT EXHIBITOR PRE FAIR FORM-**All Exhibitors that plan to show as an independent must complete a Pre-Fair Form which can be found online and must be submitted to dstornetta@kerncountyfair.com by:

HOW TO ENTER YOUR PROJECT

1: PURCHASE DNA KIT

(Market Beef, Market Sheep, Market Swine, Market Goats, Dairy Replacement Heifers, Beef Replacement Bred and Open Heifers)

Purchase a DNA Kit online for each of the above animals you will be entering in the Kern County Fair. DNA Kit will be mailed to you.

2: RETURN COMPLETED DNA KIT

(Market Beef, Market Sheep, Market Swine, Market Goats, Dairy Replacement Heifers, Beef Replacement Bred and Open Heifers)

Follow the directions within your DNA Kit and return your sample to the fairgrounds with required paperwork by the deadline for your animal.- Samples to be dropped at the P Street Office in the drop slot

3: COMPLETE YQCA CERTIFICATION

(Excluding exhibitors who only show horse, cavies, or dogs)

Go to yqca.org website, setup an account and complete the required age appropriate certification.

4: COMPLETE ONLINE ENTRY

(All Exhibitors)

You must enter your Livestock Entry online. Click the link on kerncountyfair.com website that will take you to ShoWorks online entry. The program will walk you through 7 simple steps. Online entries may be entered up until 11:59 PM on your respective closing date. Be sure to fill out all required fields. Incomplete entries will not be accepted.

** You will need to upload your YQCA Certificate

** Market Exhibitors will need to upload a photo of their animal for the auction and add-on site

*** Market Swine Exhibitors will need to upload their Prop 12 Certification

**Independent Exhibitors will need to upload a photo of the animal with the tag visible in its ear and a bill of sale.

JUST A REMINDER:

If you have a registered animal, be sure to have original registration papers in only the exhibitors name for check in at Fair.

YQCA REQUIREMENT

In order to participate in a youth livestock program (excluding horse, cavies & dogs) at any California Fair, all exhibitors 9 years of age and older must obtain annual certification in the Youth for the Quality Care of Animals (YQCA) program. Those not certified are not eligible to participate at a California Fair.

Youth for the Quality Care of Animals (YQCA), to meet this new state requirement. Agricultural universities as well as partners in the agriculture industry designed this program. By the end of 2018 over 50,000 youth across the nation will have taken a YQCA course. YQCA courses are age and level specific which allow for changing content each year. The program is offered online at yqca.org. All registration, fees, and certification are managed through YQCA.

The YQCA program has many benefits to exhibitors:

- Increase the educational preparedness of exhibitors.
- Adds another layer of quality assurance to improve sportsmanship, animal wellbeing and food safety for animal purchasers.
- Helps demonstrate our commitment to the educational development of exhibitors.
- Provides a nationally available program that any youth exhibitor can access.

This program is becoming nationally recognized so by adopting this program it also allows exhibitors to use this certification for showing at other fairs besides Kern County Fair; such as the California State Fair.

Upon completion of the training; exhibitors will receive a certificate with a unique certification number. Exhibitors can email or print their certificate for show entries. Show managers will be able to utilize the public interface through YQCA to verify the exhibitors certificate number.

All exhibitors' ages 9 and older (excluding horse, cavies and dogs) must have completed the YQCA certification by the close of entries for their given species.

Without the YQCA certificate number and certificate you will not be able to complete your entry and thus will be ineligible to show at the fair.

FACT SHEET

Overview

The U.S. Department of Agriculture's Farm Service Agency (FSA) makes operating loans of up to \$5,000 to eligible individual youths ages 10 to 20 to finance income-producing, agriculture-related projects. The project must be of modest size, educational, and initiated, developed, and carried out by youths participating in 4-H clubs, FFA, tribal youth organizations, or similar agricultural-affiliated groups.

The project must be an organized and supervised program of work. It must be planned and operated with the assistance of the organization advisor, produce sufficient income to repay the loan, and provide the youth with practical business and educational experience in agriculture-related skills.

Who May Borrow

To qualify for a loan, the applicant must:

- Comply with FSA's general eligibility requirements; and
- Conduct a modest income-producing project in a supervised program of work.



How Loan Funds May Be Used

These loans can finance many kinds of income-producing agricultural projects. The loan funds may be used to:

- Buy livestock, seed, equipment, and supplies;
- Buy, rent, or repair needed tools and equipment; and
- Pay operating expenses for the project.

How It Works

To apply, the applicant must submit completed plans and budgets signed by the project advisor and parent or guardian along with the FSA application for loan assistance.

These loans:

- Have a maximum loan amount of \$5,000 (total principal balance owed at any one time cannot exceed this amount);
- Have an interest rate that is determined based on the cost of money to the federal government (after the loan is made, the interest rate for that loan will not change);
- Will be secured, in addition to promissory notes, by liens on the products produced for sale and on chattel property, including livestock, equipment, and fixtures purchased with loan funds; and
- Have a repayment schedule that varies depending on the type of project for which the loan is made. For example, if it involves raising livestock or crops, the loan is paid when the animals or produce are normally sold.
