



2025 4-H Chicken Que Incentive Guidelines

The 4-H Open House and Chicken Que is part of the 4-H experience for every 4-H family, past and present. Generations of volunteers have given tireless hours to maintain the essence of this historic event. For 64 years our county has come together on the first Sunday of May to raise funds that support the 4-H youth, events and clubs within our county while showcasing the wide variety of activities available through 4-H.

We are excited to offer the following club incentives this year!

Participation Incentive: \$100 payable to your club!

**** Both aspects below must be met to qualify for this incentive**

1. Each club must have 80% of their members sign up, show up, sign in, participate and sign out at the 2025 4-H Chicken Que.
AND
2. **EACH MEMBER** must provide one two-layer cake or angel food cake labeled to the 2025 Chicken Que. No refrigerated desserts, please.
 - All cakes must be labeled and signed in under your club name in one of the binders provided at the main cake booth. (No Drive Thru drop of cakes)
 - It is the responsibility of the person delivering the cakes to sign in each item correctly.
 - *Additional time will not be spent after the event to confirm delivery of cakes.*

*Your club's family/member count will be determined by enrollment as of February 1st, 2025 and that information will be provided to your Chicken Que Rep.

Club/Project Booth Incentive: \$50/booth (2 booths maximum)

\$100 payable to your club!

1. You must abide by all guidelines outlined in the Booth App and Info Flyer and Leader must attend Club Booth participation meeting on April 24TH.
2. Failure to return chairs and tables to the designated area, failure to remove hay, straw, droppings or garbage and/or eating in the barn area will result in forfeiture of the incentive. Bins will be provided, tools for bedding and manure removal should be brought by clubs.
3. Vehicles (*with out a pass*) on the grounds between 10- 4:30 pm or breaking down booth early will forfeit your Incentive, and your club will be suspended from participating in future club booths.

Additional Incentive: **Both aspects below must be met to qualify for this incentive**

TICKET QUOTA INCENTIVE!

Your club must meet its minimum ticket sales quota of 2 tickets per member.

At each level, increase in incentive will apply to all tickets sold over the club quota

If you sell 0-50 tickets over quota, your club will receive \$0.25/ticket (up to \$12.50)

If you sell 51-100 over quota, your club will receive \$0.50/ticket (up to \$50.00)

If you sell 101-200 over quota, your club will receive \$0.75/ticket (up to \$150.00)

If you sell 201+ over quota, your club receives \$1.00/ticket for every ticket sold over quota

AND

1. **Your club's ticket distribution form, unsold tickets and club check must be turned in to the 4-H office by the deadline on or before Tuesday May 20, 2025 by 3 PM.**

CAKE QUOTA INCENTIVE!

Your club must meet its minimum cake sales quota of 1 cake per member to be eligible.

1. Your club will be paid \$1 for each cake you label and sign in under your club's name in one of the binders provided at the main cake booth
